Golf Cart* Usage Policy and Procedures

* Includes golf carts, UTVs, ATVs, side-by-sides, 4-wheelers, etc. Four wheelers allowed for Camp Security Personnel only

PLEASE READ CAREFULLY. THIS POLICY APPLIES YEAR-ROUND.

REGISTRATION

- 1. All golf carts* MUST be registered in the District Office and cannot be operated until they are registered.
- 2. The following is required for registration:
 - a. Valid Proof of Insurance statement with a minimum of \$50,000 coverage: Bring hard copy to register
 - b. Photocopy of a valid Driver's License
 - c. Completed Golf Cart* Registration Form (download from website: ladistupc.com/resources)
 - d. \$25.00 registration fee per vehicle
- 3. At the time of registration, a "Proof of Registration" tag will be issued, which is to be placed on the vehicle where it is easily visible.

DRIVING AGE

- 1. During <u>Kids or Junior Camp</u>, drivers operating golf carts* must have a valid Driver's License and be at least age 21.
- 2. During <u>Senior Camp</u>, drivers operating golf carts* must have a valid Driver's License and be at least age 23.
- 3. During <u>Camp Meeting</u> and all other times (except Youth Camps), only those at least age 18 with a valid <u>Driver's License</u> (automobile/chauffeur) are authorized to operate golf carts* on the campground at any time.
- 4. Security may ask to see driver's license and will put a lock on any golf carts being driven by unauthorized drivers, including cases where a passenger is an authorized driver.

OPERATING RULES & REGULATIONS

- 1. Golf carts* must not have more passengers than they are designed to carry, and those passengers must be sitting in the passenger seats.
- 2. Golf carts* that are operated at night must have front and rear lights for visibility.
- 3. Golf carts* that are not in use must have steering wheel locked to cart.

TRAILERS

Cart trailers with a corresponding tag must be parked at the Albritton Field (next to the tree line) or on the Tenney Drive side of the oxidation pond.

ALL POLICIES APPLY FOR THOSE ON THE GROUNDS DURING THE WEEKENDS BEFORE/AFTER ANY CAMPS.

VIOLATION OF ANY PORTION OF THIS POLICY WILL RESULT IN SECURITY REMOVING REGISTRATION TAG FROM GOLF CART*, THUS REMOVING THE RIGHT FOR THAT CART TO BE DRIVEN. CONTINUED VIOLATION AFTER THIS POINT WILL RESULT IN REMOVAL OF CART* FROM THE CAMPGROUNDS.
